The Board of Hiremii Limited (ASX:HMI) ("Hiremii" or "the Company") has responsibility for corporate governance for the Company and its subsidiaries (the Group) and has implemented policies, procedures and systems of control with the intent of providing a strong framework and practical means for ensuring good governance outcomes which meet the expectations of all stakeholders.

This Corporate Governance Statement is current as at 28 August 2023 and has been approved by the Board of the Company on that date.
